

ACH direct payment is an effective electronic payment alternative to paper checks. When you use ACH direct payment, you authorize Service Credit Union to electronically collect a preauthorized amount from a checking account that you maintain at another financial institution. Instead of writing a check every month, Service Credit Union automatically collects the payment on a predetermined day for you, it's that simple!

HERE'S HOW ACH DIRECT PAYMENT WORKS:

You authorize regularly scheduled payments to be made from a checking account that you maintain at another financial institution. The credit may be to any savings account. Your payments are made on the specified day and proof of payment will appear on your statement. The authority you give us to charge your account will remain in effect until you notify us in writing to terminate the authorization.

- Helps meet your commitments in a convenient and timely manner - even if you're on vacation or out of town
